Training Module for Professionals-Potential Operators of CAN-MDS Surveillance System

1. Identity

This training module was developed in the context of the co-funded Daphne III Project "Coordinated Response to Child Abuse and Neglect via a Minimum Data Set" [JUST/2012/DAP/AG/3250]. Specifically, the module (D4.1) was created under the fourth workstream of the project as a result of the fifth activity and is related to third output as below:

WS4 Capacity Building: Train of Trainers and of National Core Groups of CAN-MDS

Activity 5 Conduction of training of national core groups of CAN-MDS operators at a country level

Output 3 7 1-day (8-hour) CAN-MDS trainings at a national level) (7 countries X 20 professionals/trainees)

2. Brief introduction

The fact that 'the true extent of child maltreatment is unknown' is commonly recognized in international literature. On the basis of a variety of estimations for the extent of the phenomenon "between half to four fifths of all victims of maltreatment are not known to child protection services"; the "tip-of-the-iceberg analogy easily comes to mind when one thinks of the scope of child maltreatment" (Sedlak and Broadhurst 1996; Trocmé et al. 2005)

The necessity for CAN National Surveillance Systems is advocated by the need to understand the incidence of CAN based on data deriving from services' response to CAN cases; to monitor demand for services administrating cases; to set priorities for prevention; to identify the needs of professionals involved; to understand CAN consequences; and to determine the costs associated with CAN.

The aim of the project 'Coordinated Response to CAN via MDS' is to create the scientific basis, necessary tools and synergies for supporting the establishment of CAN

National Surveillance Systems (where such mechanisms are not available) or improving of CAN National Surveillance Systems (where they exist). The means towards the aim is the developing of a proposal for a Surveillance System for Child Abuse & Neglect through recording services' responses to individual cases.

Among the projects scheduled activities towards the achievement of the aim is to build the capacity of professionals working in child protection and CAN prevention related services for collecting and sharing CAN-MDS via a short training course conducted by trained facilitartors and evaluation of trainings' effectiveness. Given that the CAN-MDS targets to collect uniform data on the basis of the MDS from all potential sources, one common training module is addressed to all potential stakeholders.

3. Aim & Objectives

To build the capacity of national core groups of CAN-MDS future operators in order for the CAN-MDS to be ready for piloting in the 7 countries (BG, BE, DE, GR, FR, IT, RO).

Specifically,

- to inform the members of National Core Groups of CAN-MDS
 - on the project and its aims
 - on what it is expected by them in the future
 - they will act as multipliers by training other eligible professionals (in case that a National CAN-MDS will be built) and therefore they should being familiarized with the specific training process

and, moreover,

- to ensure a common understanding (among professionals of core groups in different countries) of the aim and the content of the training & that a common methodology will be used in national trainings
 - to "pilot" the training module and improve it (for the national context) via the evaluation by identifying potential omissions and suggesting modifications (eliminations/ additions)



4. Trainers & Trainees

Trainers

Trainers in the workshops for the national Core-Groups of CAN-MDS Operators are the project's Local Coordinators and researchers participated in the *Train of Trainers Seminar*.

At a later phase, trained members of the national Core Groups of Operators will act also as trainers for further groups of professionals (*Expanded Groups of Operators*) –in case that a national CAN-MDS Surveillance System will be developed.

Trainees

National Core-Groups of CAN-MDS will consist from 20 professionals per country that will be selected according to the results of the respective process.

Fields should be represented in national core groups

- Core data sources for a CAN-MDS Surveillance System (all countries)
 - CPS/ Social Welfare Services
 - Health Care Services (primary, secondary & tertiary)
 - Judicial Services
- Sectors that could also be among the main data sources (depending on countries' specifics)
 - Mental Health Services
 - Accredited NGOs/ Community Organizations
 - Law Enforcement related Services
 - Educational Services (preschool, primary & secondary)
 - Already existing registries/ monitoring mechanisms (not available in all countries)

Sectors that would probably be difficult to be included as data sources because their involvement seems to be more as a country specific attribute rather than a common practice among countries

- Independent Authorities (such as Child Ombudsman)
- Research Organizations/Institutions
- Other fields

Eligible professionals' groups per sector or "working field"

Welfare related professions: Social Workers, Health Visitors, Care providers in institutions, other personnel (e.g. working in antitrafficking agencies, directorates for disability, Child Ombudsman etc.)

Justice-related professions: Judges (family courts, juvenile courts), Probation Officers, Public Prosecutors, Forensic surgeons' professionals, Lawyers, other justice related professions)

Health related professions: Medical Doctors (general doctors and specialized doctors such as gynecologists, pediatricians, orthopedists, and radiologists), Midwives, Nurses, and Dentists

Mental health professions: Child Psychiatrists, Psychiatrists, Psychologists, Licensed Counselors (Youth Counselors, Family Counselors, etc.)

Law enforcement related professions: Police Officers (in general and specialized police investigators e.g. in forensic interviews, for crimes against minors etc.)

Education-related professions: Teachers/Educators (pre-school, kindergarten, primary and secondary education, for children with special needs), School Principals

Other professionals: Researchers, Data administrators, other school personnel (e.g. school guardians), other Public officials (e.g. ministries' employees), other NGOs personnel (e.g. volunteers, priests, sisters)

At a later phase, trainees in national trainings for expanded groups of CAN-MDS operators could be eligible professionals working in related fields that will be selected according to the above mentioned criteria.
